Computer Programs

ROC Analyzer (version 6.0) - program which takes ordinal data and allows for several analyses: [1] ROC curve plotting for 1-3 curves; [2] ROC area analysis (by either a non-parametric method or by the classic maximum likelihood estimation method); [3] comparing the areas under 2 ROC curves (using the method described by Hanley and McNeil); [4] calculating likelihood ratios and their 95% confidence intervals (for each ordinal category) - Updated, Feb, 1992.

<u>Twobytwo</u> (version 1.0) - program for calculating statistics based on a 2 X 2 table, examples include: sensitivity, specificity, odds ratio, likelihood ratio, chi-square analysis, t-test for small numbers - Updated, Feb, 1992.
