a. WAC- Ben Graham:

Ben: Provost Jordan has a lot of connections and so he could help too before he leaves in July.

Josh: Definitely a huge positive step in a good direction, especially after that discussion last week.

Rick: You're going to spend the referendum money?

Ben: No. Just my job to show you that SAC is a good opportunity. Better to ask for private funding to remodel SAC and add a 2nd floor. ACS lab owned by AS. Housing owns Res Life part. When the other place opens up, they will vacate.

Housing would want to open another food shop that wouldn't compete with Earl's.
